13. Related Party

An Endowment Fund payment received during the incorporation from sponsors Tameside College as part of the original funding agreement for £666,666 was reinvested during the year resulting in interest of £nil (2021: £nil). Endowment interest is held within unrestricted funds, with a preference for these monies to be used for raising aspirations, such as promoting higher education.

Sponsors, Tameside College were paid £nil (2021: £nil) relating to alternative provision and the teaching of Engineering to Academy students.
